## Washington State Clean Buildings

The Washington state energy performance standard for covered commercial buildings will more than likely impact your building. Comments are being accepted until March 11 for sections 5 and 6 of the rule, which is based on ASHRAE Standard 100. #### Electrification of Transportation Systems Grants Available

The Washington State Department of Commerce is accepting applications for a new grant through the Electrification of Transportation Systems (ETS) program which makes available \$10.6 million to expand electric vehicle charging infrastructure in Washington state. Qualifying applicants must be a Washington state local government, a retail electric utility serving Washington state, or any organization partnering with qualified entities. Letters of Intent are due by March 5, 2020 and applications must be submitted by May 5, 2020. #### Boilers and Water Heaters

Tools such as advanced control systems and improved designs of boiler and water heater systems have helped keep such systems performing efficiently and continuously running. A four-part article written by James Piper for the February 2020 issue of *Facility Maintenance Decisions* discusses ways to make the most use of these tools. Effective staff training is crucial, and includes knowing the skills needed by operators and which skills they already have. A consistent monitoring and maintenance schedule based on the manufacturers requirements, and tracking the history of the system helps when a decision must be made about replacing or repairing a particular system.

#### **Campus Energy Efficiency**

When the state of Oklahoma passed an energy initiative for agencies and institutions to reduce energy usage by 20 percent by 2020 over the baseline usage in 2013, Tulsa Community College was challenged to meet the state requirements. A three-part article written by Dan Hounsell in the February 2020 issue of *Facility Maintenance Decisions* discusses how the college went beyond the low hanging fruit of energy efficiency by involving facilities staff as well as building engineering and maintenance staff in identifying and carrying out new measures. #### **Building Operators Certification**

BOC Level I certification is 74 hours of training and project work in building systems maintenance. Level II certification is 61 hours of training and elective coursework in equipment troubleshooting and maintenance. Classes usually meet one or two full days a month over a period of four to six months.
