Cancelled – 16th Annual WSU Energy/Facilities Connections Conference

The 16th Annual Energy/Facilities Connections Conference that was set for May 5-7 in Leavenworth was cancelled due to the current COVID-19 health crisis. The WSU Energy Program is working with conference sponsors and session leaders to identify next steps. RCM Clean Buildings Workshops

The video recording of the Clean Buildings Webinar for RCMs, which aired March 26, will be posted on the WSU Energy Program RCM webpage by April 7.

Seattle Building Tune-ups and Energy Benchmarking

The Benchmarking report deadline for the City of Seattle benchmarking requirement has been extended to July 1, 2020. Due to COVID-19, all upcoming <u>Building Tune-Up</u> 2020 deadlines have been extended six months, and hospital and medical institutions have been extended one year. In other Tune-Up news – compliance of the largest buildings, over 200,000 SF, is 95%.

Washington State Clean Buildings

Rulemaking workshops for Clean Buildings, the Washington state energy performance standard for covered commercial buildings, continue online through June. COVID-19 and the Energy Efficiency Workforce

Steven Nadel, Executive Director of ACEEE (American Council for an Energy-Efficient Economy) writes about the challenges and impacts of COVID-19 on the energy efficiency sector in a March 26, 2020 blogpost – COVID-19 is slamming efficiency workforce now, and may bring long-term changes for efficiency.

Energy Efficiency & Empty Buildings

An article titled <u>"Efficiently Empty: Maintaining Building Efficiency in Empty Buildings"</u> by Lindsey Dickes Falasca for the *Institute for Market Transformation* discusses opportunities for facilities managers to continue efficiency measures even while many buildings are empty due to the Coronavirus outbreak. Adjusting operational schedules and set points for mechanical systems, reducing phantom lighting loads, and working on deferred maintenance projects are all opportunities to continue energy efficiency efforts while building occupancy is reduced.

Utility Incentives

As the low hanging fruit of energy efficient measures continue to be picked clean, utilities are shifting more and more to offering complex and whole-building performance-based incentives. In a two-part article for the March 2020 issue of *Building Operating Management*, Ross Fairbanks explores the trend of tiered and custom incentives. Variable Frequency Drives

The acceptance of variable efficiency drives (VFDs) as an important tool in managing energy use has resulted in the expansion of the technology into more equipment that serves variable loads. Using VFDs not only helps with energy efficiency, it can also prolong the life of equipment. A set of three articles in the March 2020 issue of *Building Operating Management* written by James Piper discusses the uses and advantages of VFDs, as well as different approaches for using analytics to determine HVAC usage patterns and monitor efficiency.

Building Operators Certification

BOC Level I certification is 74 hours of training and project work in building systems maintenance. Level II certification is 61 hours of training and elective coursework in equipment troubleshooting and maintenance. Classes usually meet one or two full days a month over a period of four to six months.
